## M.Ed. Programs Offered in North Carolina Licensure Fact Sheet

### Criteria for Adding the Master's Competencies' Level Code M to an Initial North Carolina Teaching License

- The program must be an approved educational program in the state from which it is administered. Lesley's NC program offerings are approved by the MA Department of Education.

Upon successful completion of a Lesley University Massachusetts Department of Education approved program and award of the degree, the program completer must do the following:

1. Fill out a **DPI Form V** and request Lesley University's Certification Officer to sign it and recommend the program completer for North Carolina licensure.
2. To apply for Level Code M: the program completer must submit a transcript and the completed North Carolina Form V signed by the Lesley University Certification Officer with a \$55.00 fee to the North Carolina Department of Public Instruction.
